A. Discussion Related to Community Action Report from Community Meetings Related to Recent Gun Violence

Mayor Shull turned the meeting over to Council Member Cain. Council Member Cain stated "after a Town-Hall style community meeting and constructive conversations with the community, we are presenting to the community, Council, and the Town Administration a comprehensive strategy to invest in evidence-based community violence interventions to combat gun violence and other violent crimes." This strategy implements preventive measures that are proven to reduce violent crime and attacks the root causes – including by addressing education and work opportunities for teens and young adults. This strategy organizes the Council into standing committees composed of Council Members and citizens and it utilizes a portion of the US Treasury Department's American Rescue Plan funds allocated to Batesburg-Leesville. These funds are geared towards effective community policing, in addition to supporting proven Community Violence Intervention Programs, summer employment opportunities, and other investments that will reduce crime and make our neighborhoods safer.

STANDING COMMITTEES

Responding to recent gun violence in our community and hearing the concerns of B-L citizens, we propose standing Council committees to address urgent Town needs – community policing, education and work opportunities. The Committees are designed to facilitate oversight of the business of the Town of Batesburg-Leesville. Standing Committees are established under the terms set forth by the B-L Town Council. The work of the Standing Committees shall be advisory to the Council unless otherwise specified in a Committee Charter or as directed by Council.
