UPCOMING EVENTS

- Just as a reminder, the Town Egg Hunt will be held next week on Wednesday, April 13th from 5:30-7:30pm at Leesville College Park. We encourage the community to come out and take part.
- We held our 2nd Annual Spring Clean event on Saturday, March 19th from 9:00-12:00am. We had 157 people take part and were about to pick up 3 ½ tons (7,000 lbs) over the 3 hour period. A special thank you to all the churches, civic & community groups, and individuals that took part.
- As a reminder, this year's Electronic Recycling event will be held on Saturday, April 23rd from 8:00-12:00pm at the B-L High School parking lot. We will be accepting tires (limit 8), scrap metal, paper shredding, and electronic (limit 8).

SC GEODETIC SURVEY PUBLIC MEETING COMING UP

• SC Geodetic staff has completed their updated surveying of the Lexington and Saluda County lines, which I had previously reported on was being done at Saluda Counties request. There are going to be a number of changes along the line from Lake Murray to the bottom corner of our Town limits. It appears there are going to be numerous Lexington County residents whose property is going to be moved in Saluda County or a portion of their property moved into Saluda County. SC Geodetic staff is holding a public meeting for all those that will be affected from Saluda County, Lexington County, and Town of B-L. The date will be May 16th at 6:00pm here at Town Hall. SC Geodetic staff will be doing the presentation and there to address questions, comments, and concerns. This has no effect on our Town limits, just more of the Town limits moving into Saluda County it appears. SC Geodetic will take care of all mailing of meeting notices to affected property owners.

2022 CDBG GRANT APPLICATION AND C FUND REQUEST SUBMITTED TO LEXINGTON COUNTY

• We submitted to Lexington County CDBG office our request for grant funding for 2022. The request submitted is to replace the existing gas feed chlorine and sulfur dioxide equipment and storage facility. The new equipment will be liquid feed pumps, day tanks and bulk chemical tanks, a spill prevention storage facility and process monitoring equipment to assist plant operations with system controls including chemical dosing, emergency conditions, operator notifications and data archiving. This is picking up where

MANAGER'S REPORT CONT'D.

- we had previously left off, as this project was funded before, but we had to swap to new aeration equipment for basin #1 due to equipment failure. County CDBG staff has recommended this project for funding and it has passed County Council committee approval for funding in the amount of \$458,201. Total project cost is expected to be \$606,401.
- We have also submitted to Lexington County our request for 2022 C Funds in the amount of \$35,000. This would be for the replacement of approximately 1,310 feet of broken and damaged sidewalk along Summerland Avenue between Miller Street and Mitchell Street.

PROJECT UPDATES

- The Pine Street Corner parking and intersection improvement has taken the next steps over the past month. Dominion Energy has gotten their electricity placed underground and is ready to connect. AT&T has been removing their lines from the utility poles and placing underground. The two power poles will hopefully be removed here soon, which opens the door to Highway 23 resurfacing and paving of the expanded lane.
- WWTP Improvement projects continue to make progress, however we are still awaiting some materials. As for the headworks project, the new digester tank has been fully erected and installed and should be painted soon. We are still awaiting the new screw pumps to come in for that portion of the project to be completed. As for Basin #2 floating aeration project. Basin #2 has been refilled and the new aeration equipment has been installed and is in the process of having the electricity installed. This project is getting close to completion.
- As for the JMWSC project, surveying continues. It appears that things are getting closer with regards to securing property for the future tank and pump station site along Highway 1. There is an interested property owner who is working with JMWSC for the property they need.
